

**RELEASE, WAIVER, AND INDEMNIFICATION AGREEMENT FOR PARTICIPATION
IN THE CREEDE DONKEY DASH**

I intend to participate in a Pack Burro Race sponsored by the Creede & Mineral County Chamber of Commerce in Creede, Colorado.

I understand that this event will begin and end in the City limits of Creede. I understand that the race course traverses County Roads, Forest Service Roads, and hazardous mountain terrain. I understand that there will be motor vehicles moving through the area where these events take place. I understand that these activities and events present risks of personal injury, death, and property damage, including, but not limited to: personal injury, death, or property damage caused by animals, including burros; personal injury, death, or property damage caused by motor vehicles or other mechanized equipment; personal injury, death, or property damage caused by falls, such as cuts, bruises, sprains, fractures, and internal injuries; personal injury, death, or property damage caused by a multitude of other activities naturally occurring as part of the Creede Pack Burro Race. I FREELY ACCEPT AND ASSUME THE RISK OF ALL SUCH DANGERS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE, OR ANY LOSS RESULTING THEREFROM.

I understand that, under Colorado law, equine professionals and sponsors of equine activities are protected from liability to participants for personal injury, death, or property damage resulting from the inherent risks of equine activities pursuant to section 13-21-119, Colorado Revised Statutes. I further understand and agree that the burro race in which I will participate is an equine activity and that the Town of Creede, the Creede & Mineral County Chamber of Commerce, and Western Pack Burro Association is the sponsor of this race within the meaning of section 13-21-119. In consideration of being allowed to participate in and/or observe the activities described above, I hereby agree that I will have no claims of liability of any nature whatsoever against: Laughing Valley Ranch; any volunteers of Laughing Valley Ranch; the Western Pack Burro Association; the Town of Creede and all land owners; the Creede & Mineral County Chamber of Commerce; or Mineral County. The entities, organizations, and individuals identified above will be collectively referred to herein as "RELEASEES." I further agree that I will indemnify and hold harmless the releasees from any claims of liability arising out of or relating to my participation in and/or observance of the activities described above.

I UNDERSTAND THAT THIS AGREEMENT IS A COMPLETE RELEASE AND WAIVER OF LIABILITY AGAINST ALL OF THE RELEASEES AND THAT I AM HEREBY FOREVER RELEASING, DISCHARGING, AND HOLDING HARMLESS THE RELEASEES FROM ANY AND ALL CLAIMS OF LIABILITY OF ANY NATURE WHATSOEVER RELATING TO THE EVENTS AND ACTIVITIES DESCRIBED ABOVE, INCLUDING BUT NOT LIMITED TO CLAIMS OF PERSONAL INJURY OR DEATH, PROPERTY DAMAGE, OR ANY OTHER LOSSES, WHETHER KNOWN OR UNKNOWN, FORESEEABLE OR UNFORESEEABLE, EXISTING NOW OR IN THE FUTURE, OR ARISING DIRECTLY OR INDIRECTLY FROM THE ACTIVITIES DESCRIBED ABOVE.
