LOCAL VENDOR BOOTH INFORMATION

DATE: Saturday, May 25th and Sunday, May 26th, 2019

WHERE: Main Street, downtown Creede, Colorado

SPACE: 10' x 10' area for \$30 for one day or \$50 for both days. Booth locations will be assigned in the order of registration and payment received. Actual size of area is at least 11' x 11'.

CHECK-IN and

SET-UP: You may check-in Friday afternoon at the Chamber of Commerce building (904 South Main St.) or Saturday/Sunday morning, at which time we will be uptown setting up the area. You may set up as early as 8:00 a.m. on Saturday or Sunday mornings. The festivities will begin around 10:30 a.m.

FEES: All fees are to be submitted at the time of registration. Arrangements may be made to pay one-half of the fee by the deadline of May 15, 2019, and the remaining one-half on the day you set-up your booth. Call 719-658-2374 if you need to make payment arrangements. All fees must be paid in guaranteed funds (**cashier's check or bank money order**). If payment is made via personal check – any returned checks will incur a fee of \$25.00. Any form of payment aside from cash, should be made payable to Creede & Mineral County Chamber of Commerce.

Cancellations MUST be in writing. Written cancellations received on or before May 18, 2019 will be refunded eighty percent (80%) of the registration fee. Registration fees are non-refundable if cancellation notice is received after May 20, 2019.

REQUIREMENTS: Each vendor MUST have a Colorado Sales Tax License or Colorado Special Events License. No exceptions will be made. **You will not be allowed to set up until we have a copy of your sales tax number.** You must pay state sales tax, Mineral County sales tax (2.6%), and City of Creede sales tax (2.0%) on all sales.

LODGING: If you are planning to stay the night, you should make your reservations as soon as possible. Please contact us at 719-658-2374 for lodging information or visit our website at www.Creede.com and link to "Places to Stay".

TAKE-DOWN: Vendors must be packed, and their area cleaned by the evening of Sunday, May 26, 2019.

OTHER: All vendors are responsible for their display area; for set-up, tear-down, and clean-up of their booth space. Booth spaces not cleaned will be assessed a clean-up fee. We do not provide any electricity; however, you may run a small generator. The Creede-Mineral County Chamber of Commerce and the Taste of Creede, A Festival of Fine Arts and Fine Dining assume no responsibility for your equipment, inventory, or other property.

NOTES: The wind can blow hard here at any given time. If you have a tent, you should have extremely strong tie-downs and heavy weights. Stakes will not be allowed. **If you are found with stakes in the ground/pavement you will be fined.**
